1. Introduction

The OCRE project organises 3 open calls for projects to stimulate the adoption of Infrastructure Cloud services made available by OCRE through the EOSC portfolio of commercial services. These services are currently being procured by the OCRE project with the list of suppliers to be published in December 2020.

OCREs adoption funding will be made available in three waves:

- Wave 1 targeting individual researchers
- Wave 2 targeting research projects at individual institutions
- Wave 3 targeting research projects with groups of institutions represented by a lead buyer

This document is describes important guidelines governing this call.

5. Target group for this call

This is the 1st open call for adoption of infrastructure cloud services by Wave 2 projects, which targets research projects from individual institutions.



6. What can OCRE fund?

OCRE's adoption funding is for purchases from the OCRE laaS+ framework agreements:

- Infrastructure Cloud services
 - o laaS, PaaS, SaaS and marketplace
- Consulting services in support of using these Infrastructure Cloud Services
 - o On-boarding, assist with solution architecting etc.

In this 1st Wave 2 call, 100% of the consumption of services mentioned above can be funded by OCRE.

OCRE is currently conducting the evaluation of its pan-European procurement for the laaS+ framework agreements mentioned above. The exact list of suppliers and platforms available in each participating country will be published in December 2020.

7. What is not covered by OCRE funding?

Your project's person-hours are not eligible for OCRE funding.

OCRE's underlying assumption is that the use of commercial digital services will have a positive impact on your research project and/or the execution of the project (less time, lower cost, better quality). OCRE adoption funding is meant to stimulate the use of commercial digital services in your research, not to fund the research itself.

8. Eligible institutions

Any institution eligible to procure services from the OCRE infrastructure-cloud framework agreements is eligible for OCRE adoption funding. In practice this means if your institution is a member organisation of one of the 39 NRENs (National Research and Education Network) listed in the table below, you can assume to be eligible. Please note that we are aware of some exceptions to this rule, so if in doubt please contact your local NREN, or contact the OCRE funding call helpdesk.

9. What is OCRE looking for?

OCRE wants to demonstrate the benefits of using commercial infrastructure cloud service in research. To achieve this, OCRE looks for research-relevant projects that really show the research community how OCRE's portfolio of services can help to achieve great research outcomes, e.g.

- new outcomes enabled by services
- improved execution: time, money, quality
- impact amplifier allow nimble groups to do large undertakings
- allow for nimble budgets to achieve great things

These projects should, besides generating good research outcomes, allow OCRE to create **inspiring** showcases; case studies which inspire other researchers to adopt infrastructure cloud services for <u>their</u> research.



10. Evaluation

After an eligibility check, OCRE will prioritise the following in its evaluation of proposals:

- The show case effect
 - Of your research
 - o Impact of commercial infrastructure services on your research
- Timely use of services and achieve impact on your research
 - Months, not years. Sooner = better
- Ability to execute

Proposals will be evaluated based on their potential to clearly illustrate the benefits of consuming commercial cloud services. This means that only proposals that successfully address the this will have a chance of being funded.

Please take advantage of the different communication instruments offered by the OCRE Consortium (i.e. info sessions, Q&A helpdesk at funding@ocre-project.eu) to receive direct feedback on any questions you may have before submitting your proposal

Decisions pertaining to the evaluation, awarding and funding of successful proposals are made at the discretion of the OCRE funding team and the OCRE EAB (External Advisory Board) and will be final.

Successful research projects will agree to interviews with the OCRE team responsible for developing related case studies.
